Central Resources, Inc. intends to plug the well in accordance with regulations. Production equipment will be removed and the well will be plugged as specified. Perforate and squeeze will be used unless casing can be recovered over the specified interval.

Proposed procedure:

- Notify the Farmington BLM office at 505-599-8907 24 hours prior to commencement of plugging operations.
- Spot a cement plug through tubing from 4650' - 4753' to cover Gallup top @ 4753'.
- Perforate and squeeze cement from 2000' - 2095' to cover the Mesaverde top @ 2095' inside and outside the casing.
- Perforate and squeeze cement from 1100' - 1230' to cover the Pictured Cliffs top @ 1230' inside and outside the casing.
- Perforate and squeeze cement from 800' - 900' to cover the Frutiland top @ 900' inside and outside the casing.
- Perforate and squeeze cement from 150'-225' to cover the surface casing shoe inside and outside the production casing.
- Perforate and squeeze cement from surface to 50' inside and outside the production casing.
- Cut wellhead and install dry hole marker. Clear and remediate location.
