RIH w/retainer set @ 1885' - could not pump below retainer sting out. Pumped 20 sx Class "B" cement above retainer. POOH w/13-jts - circulate hole clean @ 1514' w/33 bbls H₂O. POOH w/tubing. RIH w/bond log tool. Log from 1500' to 150' - had good cement behind casing from 1426' to 510'. RIH w/41-jts to 1267' - decided to combine 2 plugs into one - pump 58 sx Class "B" cement inside casing - calc top to 770. POOH w/ tubing. RIH w/wireline - perf. @ 244'. Nipple up - pump 90 sx Class "B" cement to surface. Plugging complete. Witnessed by Kevin Schneider BLM - Farmington Office and Jim Walker NMEPA.
