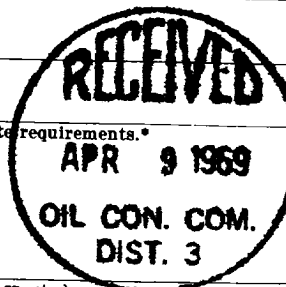

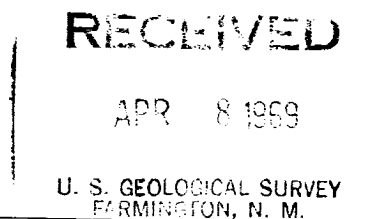

Instructions
