Gentlemen:

To date no report of operations other than electric logs have been received by this office pertaining to wells No. 300 Madge, NWNE sec. 8, T. 25 N., R. 11 W., and No. 301 Madge, NWSW sec. 9, T. 25 N., R. 11 W. San Juan County, New Mexico. Petroleum Information reports indicate the wells have both been completed.

Your notice of intent to drill form was approved with the understanding that the amount and method of cementing the production casing would be submitted at a later date, but prior to running. Since Shell has apparently completed the wells with a single-stage cement job, it will be necessary to show, to the satisfaction of this office, that the upper Cretaceous has been adequately protected. If this cannot be done, and the wells prove productive, the upper zone will have to be perforated and squeeze-cemented.
