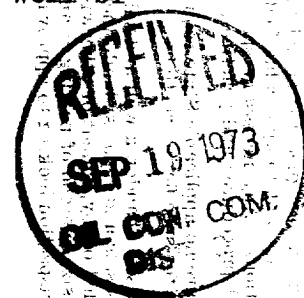

Break down pressure 3900 Psi, avg. treating pressure 4300 psi, avg. treating rate 15.6 BPM. Well SI pending AOF.
