EUE casing and cemented in two stages. Stage 1: 200 sacks Halib. light and 100 sacks class "C" latex. Plug down 12:30 am. 8/18/73. Stage 2: 250 sacks Halib. light. Plug down 8:30 am. 8/18/73. Good circulation throughout both stages. Released rig 9:00 am. 8/18/73. Waiting on completion unit.
