Flushed Bisti Lower Gallup Formation with 400 bbls oil. Recovered 160 bbls. oil and zone turned to 100% water. Zone tested non-productive. Plan to squeeze off Gallup perforations from 5011' - 5021', test squeeze to 2000# for 20 minutes, drill out cement retainer @ 5816' and drill cement to 5950'. Reopen Dakota zone from 5900' to 5908' and test zone. Also, perforate top of Dakota from 5812' to 5816' and test by fracing and swabbing

Instructions
