Plugging Summary:

Notified BLM on 1/6/99

- 1-12-99 Road rig and equipment to location, RU. Layout relief line to pit. Check well pressures: casing 80# and tubing 30#, bleed well down. POH and LD 21 joints 1-1/4" tubing and seating nipple. Plug #1 with 28 sxs Class B cement pumped down 2-7/8" casing from 668' to surface, final squeeze pressure 80#. SDFD.
- 1-13-99 Safety Meeting. Open up well, no pressure. Tag cement at 48'. Cut off wellhead. Fill casing and install P&A marker with 10 sxs Class B cement. No BLM representative was on location.
