Pull and laydown all production equipment. Set a CIBP @ 4640'. Spot cement of top to 4590'. Set a 200' cement plug across the Mesa Verde from 1772' to 1972'. Pressure test casing to 1000#. Shut well in and wait on approval on the Right of Way for the pipeline.. Upon approval - we will complete in the Fruitland Zone.
