Spudded surface at 3:00 p.m. on September 7, 1990. Drilled 8-3/4" hole to 137'. Ran 3 jts. (135') of 7", 20#, J-55, 8rd, ST&C casing. Set casing at 136'. Mixed and pumped 60 sks. (70.8 cu. ft.) Class "B" cement containing 2% CaCl<sub>2</sub> and 1/4#/sk. cellophane flakes. Cement circulated to surface. Pressure tested casing to 600 psi for 30 minutes; test ok.
