Central Resources, Inc. intends to plug the well in accordance with regulations. Production equipment will be removed and well will be plugged as specified. Perforate and squeeze will be used unless casing can be recovered over the specified interval where there is evidence cement is in place behind the casing.

Proposed Procedure:

- A.. Notify the Farmington BLM office at 505-599-8907 24 hours prior to commencement of plugging operations.
- B. Pull all retrievable downhole production equipment.
- C. Set a CIBP at 4947 and spot cement on top to 4897' to 4997'
- D. Set a 100' cement plug from 2499' to 2599' across Menefee top at 2549' inside and outside 4 1/2" casing
- E. Set a 100' cement plug from 1113' to 1213' across Pictured Cliffs at 1163' inside and outside 4 1/2" casing.
- F. Set a 100' cement plug from 1067' to 1167' across the Fruitland Coal at 1117' inside and outside 4 1/2" casing.
- G. Set a cement plug from surface to 192' to 292' across the surface casing shoe at 242' inside and outside 4 1/2" casing.
- H. Cut wellhead and install dry hole marker. Clear and remediate location.
