W/15 bbls H2O, pump 50 sx Class "B" cement w/1% CaCl, 1/4# sx Celloflake. POOH w/40 jts tubing. RIH w/tubing - tag cement plug @ 4158'. POOH w/tubing. RIH w/wireline perf @ 1947'. RIH w/retainer and tubing - land @ 1885'. Pressure up csg to 500 PSI - held. Stung into retainer and started pumping outside csg @ 650 PSI - something broke. Started getting circ up casing. Closed casing- pumped 50 sx Class "B" cement inside and outside casing. POOH w/tubing. RIH/CIBP - set @ 1236'. Pressure up casing to 500 PSI - held good. pump 38 sx Class "B" cement to 745'. POOH w/tubing. RIH w/wireline perf. @ 266'. Nipple up -est circ and pump 89 sx Class "B" cement to surface inside and outside casing. Plugging complete. Witnessed by Kevin Schneider with the BLM - Farmington Office.
