Elm Ridge Resources, Inc proposes to plug and abandon the CBU WI # 77 in accordance with regulations. Production equipment will be removed from the well and tubing will be used to pump plugs. Perforate and squeeze will be used unless casing can be recovered over the specified interval. Proposed procedure: Notify BLM office 24-hours prior to commencement of plugging procedure. Set a cement plug from 4610' to 4830' across Gallup top @ 4661'. Set a 100' cement plug from 1811' to 1911' across Mesa Verde top of 1811' inside and outside of 4-1/2 casing. Set a 200' cement plug from 1078' to 1278' across PC/FC tops @ 1128' FC and 1160' PC inside and outside aof 4-1/2 casing. Set surface plug from surface to 340' across Ojo Alamo top @ 290' inside and outside 4-1/2 casing. Cut off wellhead. Install dryhole marker. Clear and remediate well location.
