Central Resources, Inc. intends to plug the well in accordance with regulations. Production equipment will be removed and the well will be plugged as specified. **Perforate and squeeze will be used unless casing can be recovered over the specified interval or there is evidence cement is in place behind the casing.**

Proposed procedure:

- Notify the Farmington BLM office at 505-599-8907 24 hours prior to commencement of plugging operations.
- Pull all retrievable downhole production equipment.
- Set a CIBP at 5850' and spot 50' of cement on top.
- Set a CIBP at 4950' and spot 50' of cement on top.
- Spot a 100' cement plug from 4920' to 4820' across the top of the Upper Gallup at 4870'.
- Spot a 100' cement plug from 2870' to 2770' across the top of the Menefee at 2820'.
- Spot a 100' cement plug from 1368' to 1268' across the top of the Pictured Cliffs at 1318'.
- Spot and/or squeeze a 100' cement plug from 487' to 387' across the 8 5/8" csg shoe at 437'.
- Spot and/or squeeze a 50' cement plug from 50' to surface.
- Cut wellhead and install dry hole marker. Clear and remediate location.
