At the request of the Bureau of Land Management, Hixon Development Company is seeking administrative approval to drill two Pictured Cliffs formation gas wells in unorthodox locations. The request to Hixon was made during predrill inspections of the locations of the Carson Unit Well No. 207 and No. 208. Contingent upon your approval they will be drilled 1950' FSL, 1800' FEL, Section 10, T25N, R12W, and 1930' FSL, 1830' FWL, Section 10, T25N, R12W, respectively. Approval is sought on the basis of Topographic condition and in order to avoid locating pits close to or in existing washes, as illustrated on the attached topographic map.




