TIH with Bit and scraper, tagged up at 6662', unable to make any hole, TOH with bit and scraper, TIH with pump bailer and CO to PBTD 6705'. TOH with bailer.

TIH with TBG and Landpump SQ. RU pump truck and mixed and pump 52 BBls 2% KCL with 110 Gal of WA 839L. Pump 1045 gal of ASOL P-38. Disp with 46 BBls of 2% KCL. 10 BBls into displacement Pressure went from 0-800psi. Waited 1.5 hrs. pr dropped to 0 psi on TBG. Filled pump 2 gal of WA517, TIH with pump and rods, spaced out pump.
