Elm Ridge Resources, Inc. proposes to plug and abandon the Andy Williams #1 in accordance with regulations. Production equipment will be removed from the well and tubing will be used to pump plugs. Perforate and squeeze will be used unless casing can be recovered over the specified interval. Proposed procedure as follows: Notify the BLM 24-hours prior to commencement of plugging operation. Set a CIBP @ 4400' inside 5-1/2 casing. Set a 50' cement plug from 4350' to 4400' inside 5-1/2 casing. Set a 100' cement plug across Mesa Verde from 1688' to 1788', top @ 1738' inside 5-1/2 casing. Set a 200' cement plug across top of PC from 876' to 1076', top @ 1026' inside 5-1/2 casing. Set a 211' cement plug across top of PC/FC from 865' to 1076', top PC @ 1026', top FC @ 915' inside 5-1/2 casing. Set a cement plug from surface to 330' inside 5-1/2 casing. Cut wellhead off. Install dryhole markers. Clear and remediate location.
