Spudded surface at 11:00 A.M. on September 13, 1990. Drilled 8-3/4" hole to 130'. Ran 3 jts. (120.43') of 7", 20#, J-55, 8rd, ST&C casing. Belled pin on 1st jt. Casing set at 121.93'. Mixed and pumped 60 sks. (70.8 cu. ft.) of Class "B" cement containing 2% CaCl<sub>2</sub> and 1/4#/sk. cellophane flakes. Cement circulated to surface. Pressure tested casing to 600 psi for 30 minutes; test ok.
