12/9/94 Set 117 sack (138.1 cuft) cement plug from 1178' to surface.
Pressured up to 1400 psi. Shut well in.

12/29/94 Installed regulation dry hole marker and cleaned location.

Note: Cement was Class "B" cement mixed at 15.8 ppg, 1.18 cuft/sk yield.

Casing remaining in hole:

Surface casing: 7", 20#, J-55 to 128'

Production casing: 4-1/2", 9.5#, J-55 to 1341'
