13. Describe Proposed or Completed Operations

Central Resources Plugged & Abandoned this well per the following:

- 1-27-99 MO, RU. Layout relief line to pit. Pressures: casing 40# and tubing 20#; blow well down. ND wellhead and NU BOP. TOH and LD 35 joints 1-1/2" tubing. RD and MOL with rig. Pump 20 bbls down casing. Plug #1 with 99 sxs Class B cement pumped down 4-1/2" casing to 1205' to fill perforations, did not displace; final pressure 300#. Shut in well and WOC.
- 2-3-99 Cut off wellhead and found cement at surface. Installed P&A with 12 sxs Class B cement. J. Morrison, BLM was on location.
