Giant Exploration & Production plugged and abandoned the subject well as follows:

12/9/94 Set 115 sack (135.7 cuft) cement plug from 1165' to surface.
Topped off with 9 sacks (10.6 cuft). Shut well in.

12/29/94 Installed regulation dry hole marker and cleaned location.

Note: Cement was Class "B" cement mixed at 15.8 ppg, 1.18 cuft/sk yield.

Casing remaining in hole:

Surface casing: 7", 20#, J-55 to 127'

Production casing: 4-1/2", 9.5#, J-55 to 1300'
