Elm Ridge Resources, Inc proposes to plug and abandon the Carson Unit 19 #44 in accordance with regulations. Production equipment will be removed from the well and tubing will be used to pump plugs. Perforate and squeeze will be used unless casing can be recovered over the specified interval. Proposed procedure: Notify the BLM office 24-hours prior to commencement of plugging procedure. Set a CIBP @ 4690'. Spot a cement plug from 4630' to 4690'. Set a 100' cement plug from 1922' to 2022' across top of Mesa Verde top @ 1972' inside and outside of 5-1/2 casing. Set a 100' cement plug from 1160' to 1260' across top of PC top @ 1210' inside and outside 5-1/2 casing. Set a 100' cement plug from 1010' to 1110' across top of FC top @ 1060' inside and outside of 5-1/2 casing. Set a 100' cement plug from surface to 360' across top of Ojo Alamo top @ 310' inside and outside of 5-1/2 casing. Cut off wellhead. Install dryhole markers. Clear and remediate location.
