Drilled out from under casing with 6-1/4" bit September 4, 1990. Drilled to TD of 1500'. Ran Compensated Density-Neutron logs with gamma ray. Log tops as follows: Fruitland - 1160', Basal Fruitland Coal - 1340', Pictured Cliffs - 1392'. Ran 36 jts. (1503.30') of 4-1/2", 9.5#, J-55, 8rd, ST&C casing. BakerLoked cement nosed guide shoe on bottom and insert flapper float on top of 1st jt. BakerLoked the pin of 2nd jt. Ran centralizers on tops of 1st, 3rd, 5th, 7th, and 9th jts. Casing set at 1499.19', PBD at 1464.54'. Cemented casing as follows: Mixed and pumped 80 sks. (164.8 cu. ft.) Class "B" cement containing 2% Thriftyment and 1/4#/sk. cellophane flakes. Tailed in with 85 sks. (100.3 cu. ft.) of Class "B" cement containing 2% CaCl2 and 1/4#/sk. cellophane flakes. Cement circulated to surface. Pressure tested casing to 3500 psi for 15 minutes. Test ok. Waiting on completion operations.
