Drilled out from under casing with 8-3/4" bit February 18, 1991. Drilled to TD of 6098'. No logs run. Ran 13 jts. (564.51') of 5-1/2", 17#, J-55, 8rd, LT&C slotted casing, 21 jts. (925.93') of 5-1/2", 17%, J-55, 8rd, LT&C casing, 5-1/2" x 7" swedge, and Baker Model SLP-R liner hangar. Hangar set at 4598.63'. Pressure tested 9-5/8" casing and liner hangar to 1200 psi for 15 minutes. Test ok. Waiting on completion operations.
