Drilled out from under casing with 6-1/4" December 5, 1990. Drilled to TD of 1235'. Ran Compensated Density-Neutron logs with caliper and gamma ray. Log tops as follows: Fruitland - 865', Basal Fruitland Coal - 1052', Pictured Cliffs - 1099'. Ran 29 jts. (1229.98') of 4-1/2", 9.5#, J-55, 8rd, ST&C casing. BakerLok cement nosed guide shoe on bottom and insert flapper float on top of 1st jt. Ran centralizers on tops of 1st, 3rd, 5th, 7th, and 9th jts. Casing set at 1227.67', PBD at 1184.35'. Cemented casing as follows: Mixed and pumped 70 sks. (144.2 cu. ft.) Class "B" cement containing 2% Thriftyment and 1/4#/sk. cellophane flakes. Tailed in with 65 sks. (76.7 cu. ft.) of Class "B" cement containing 2% CaCl₂ and 1/4#/sk. cellophane flakes. Cement circulated to surface. Pressure tested casing to 3500 psi for 15 minutes. Test ok. Waiting on completion operations.
