Drilled out from under casing with 7-7/8" bit November 14, 1990. Drilled to TD of 5025'. Ran Induction Log and Compensated Density-Neutron logs with calliper and gamma ray. Log tops as follows: Fruitland - 952', Basal Fruitland Coal - 1129', Pictured Cliffs - 1169', Lewis - 1296', Cliffhouse - 1929', Menefee - 2518', Pt. Lookout - 3594', Mancos - 3797', Gallup - 4660'. Ran 112 jts. (5015.11') of 5-1/2", 15.5#, K-55, 8rd, LT&C casing. BakerLok cement nosed guide shoe on bottom and differential fill float collar on top of 1st jt. Ran centralizers on 1st jt. and tops of 3rd, 5th, 7th, 9th and 11th jts. Casing set at 5010.36', PBD at 4964.95'. Cemented casing as follows: Mixed and pumped 450 sks. (1750 cu. ft.) Class "B" cement containing 3% Econolite and 1/4#/sk. cellophane. Tailed in with 200 sks. (236 cu. ft.) of Class "B" cement containing 2% CaCl and 1/4#/sk. cellophane. Cement circulated to surface. Pressure tested casing to 3500 psi for 15 minutes. Test ok. Waiting on completion operations.
