Spudded surface at 1:00pm on November 17, 1990. Drilled 8-3/4" hole to 134'. Ran 3 jts. (132.45') of 7", 20#, J-55, 8rd, ST&C casing. Casing set at 134'. Mixed and pumped 60 sks. (70.8 cu. ft.) of Class "B" cement containing 2% CaCl<sub>2</sub> and 1/4#/sk. cellophane flakes. Cement circulated to surface. Pressure tested casing to 600 psi for 30 minutes; test ok.
