Spudded surface at 11:30 am on March 12, 1991. Drilled 8-3/4" hole to 131'. Ran 3 jts. (130.30') of 7", 20#, J-55, 8rd, ST&C casing. Casing set at 130.80'. Mixed and pumped 60 sks. (70.8 cu. ft.) of Class "B" cement containing 2% CaCl₂ and 1/4#/sk. cellophane flakes. Cement circulated to surface. Pressure tested casing to 600 psi for 30 minutes; test ok.
