Plug #1 with 81 sxs Class B cement pumped down 2-7/8" casing to 968' to fill perforations, did not displace; shut well in with 100#. WOC. Dig out and cut off wellhead. Found cement at surface. Install P&A marker with 4 sxs Class B cement. MOL.
