Plugged and abandoned well on 09/28/95 by setting a cement plug from 1171' to surface with 105 sxs of Class B cement + 4% gel mixed @ 14.2 ppg w/FW. Cut 5 1/2" and 8 5/8" casings off 5' BGL. Welded steel plate over casing tops to cover casings. Installed a dry hole marker with proper well identification. Dressed and reseeded location as per BLM requirements on 12/01/95.
