Spudded well on October 26, 1992. Drilled 8-3/4" hole to 132'. Ran 3 jts. (129.90') 7", 20#, J-55, 8rd, ST&C casing. Casing set at 130.40'. Mixed and pumped 60 sks. (70.8 cu ft.) Class "B" cement containing 2% CaCl₂ and 1/4#/sk cellophane flakes. Circulated cement to surface. Pressure tested to 600 psi for 30 minutes; test okay.
