Ran 3 jts. (126.60') 7", 20#, J-55, 8rd, ST&C casing. Casing set at 128.10'.  
Mixed and pumped 60 sks. (70.8 cu ft.) Class "B" cement containing 2% CaCl<sub>2</sub>  
and 1/4#/sk cellophane flakes. Circulated cement to surface. Pressure tested  
to 600 psi for 30 minutes; test okay.
