Move in & rig up Smith Drilling. Spudded 9-1/8" hole at 1130 hrs 5/27/97. Drilled 0-135'. Circulate hole clean. TOH with bit. TIH with 3 jts. 7" S-95 26# casing landed at 122'. Pump 5 bbls water. Cement with 50 sx class "G" neat w/2% CaCl₂. Displace with 4 bbls water. Plug down @ 1630 hrs 5/27/97. Shut in for night.

Nipple up BOP. Pressure test casing to 600# - held OK.
