9/29/98- Ran 139 jts new 4-1/2", 10.5#, J-55, STC csg and set @ 6220'. RU Dowell
9/30/98 Schlumberger and cemented in 2 stages. First stage: 350 sxs C1 B cement w/3% D79 and 1/4 pps celloflake followed w/160 sxs C1 B cement containing 5 pps D42 and 1/4 pps celloflake. Displaced cement w/98 bbls mud and fresh water. Plug down w/1250 psig @ 6:15 a.m., 9/30/98. Open DV tool @ 2208'. Circulated thru DV tool. Did not circulate cement to surface between stages. Second stage: 250 sxs C1 B cement containing 3% D79 and 1/4 pps celloflake followed w/100 sxs C1 B cement containing 5 pps D42 and 1/4 pps celloflake. Displaced cement w/35 bbls fresh water. Plug down @ 11:05 a.m., 9/30/98. Tested float to 1559 psig, held OK. Did not circulate cement to surface. ND BOP's, set slips, cut off 4-1/2" casing, jet pits and released rig @ 3:00 p.m., 9/30/98.

Ran temperature survey and found TOC @ 252'. WOC.
