Cemented w/300 sxs Cl "B" cement w/2% CaCl₂ & 1/4#/sx Celloflake. Displaced cement w/18 bbls fresh water. Plug down @ 12:30 a.m., (MST), 10/02/98. Float did not hold. Circulated 131 sxs cement to surface. WOC 12 hrs.
