Cemented w/225 sxs C1 B cement w/2% CaCl₂ and 1/4#/sxs Celloflake. Displaced cement w/18.4 bbls fresh water. Plug down @ 11:15 p.m. (MST), 10/12/98 w/100 psig. Float did not hold. Circulated 85 sxs cmt to surface. WOC 12 hrs.
