RU Dowell/Schlumberger and cemented w/225 sx C1 B cement w/2% CaCl₂ and 1/4#/sx Celloflake. Displaced cement w/19 bbls fresh water. Plug down @ 12:01 a.m., 10/25/98, w/160-psig. Float held OK. Circulated 20 sx cement to surface. WOC 4 hrs. Prep to NU BOP and drill ahead w/7-7/8" bit.
