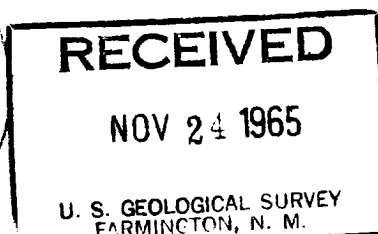
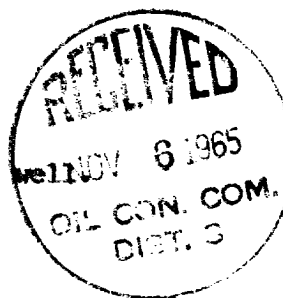

Instructions

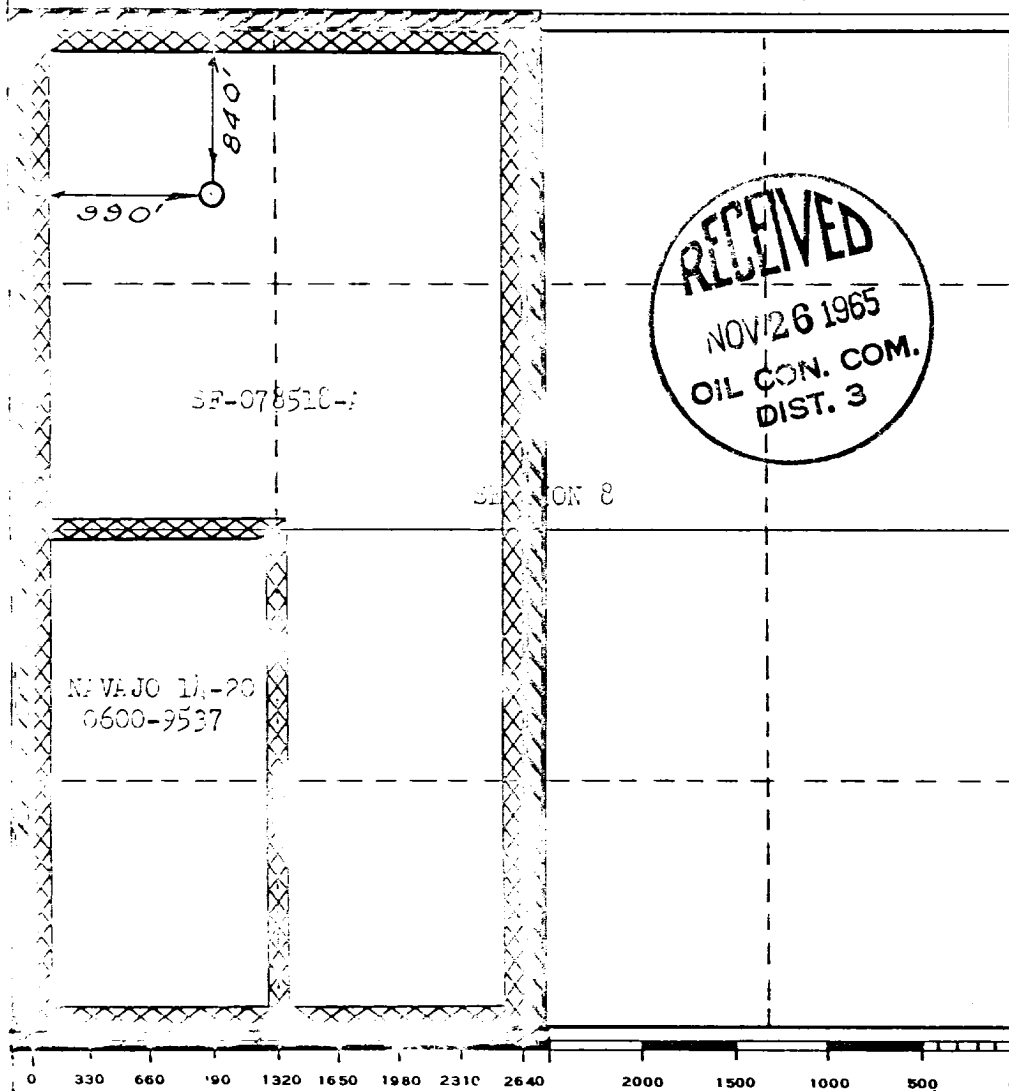
