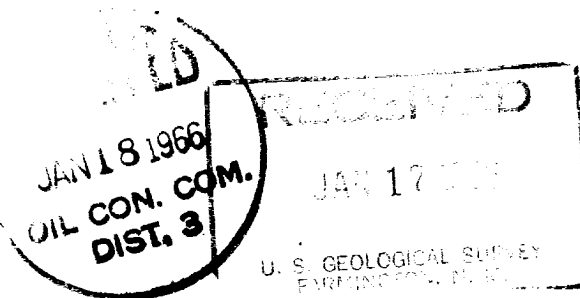

Max. pr. 4000#, HDP 2000#, tr. pr. 4500-3500-3900#. Dropped 4 sets of 16 balls each. I.R. 35.3 BPM, flushed w/5040 gallons water. ISIP 2250#, 5 Min. SIP 2000#.
