


THE APPLICATION OF MAGNOLIA

CLIFFS FORMATION.

ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 112-A (c) Magnolia Petroleum Company made application to the New Mexico Oil Conservation Commission on October 24, 1958, for permission to dually complete its Jicarilla "G" Well No. 6, located 990 feet from the South line and 990 feet from the West line of Section 36, Township 27 North, Range 3 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to permit the production of gas from the Blanco Mesaverde Pool and the production of gas from an undesignated Pictured Cliffs formation.

Now on this 17th day of November, 1958, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Sub-section 'c' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, Magnolia Petroleum Company, be and the same is hereby authorized to dually complete its Jicarilla "G" Well No. 6, located 990 feet from the South line and 990 feet from the West line of Section 36, Township 27 North, Range 3 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to permit the production of gas from the Blanco Mesaverde Pool and the production of gas from an undesignated Pictured Cliffs formation, through parallel strings of tubing.

PROVIDED HOWEVER, that applicant shall complete, operate and produce said well in accordance with the provisions of Section V, Rule 112-A, as amended by Order R-1214.

PROVIDED FURTHER, that applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test Period for the Blanco Mesaverde Pool.

IT IS FURTHER ORDERED: that jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem

ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 112-A of the Oil Conservation Regulations, the Commission on October 24, 1958, for permission to dually complete the Liberty Well No. 1, located 990 feet from the South line and 990 feet from the West line of Section 35, Township 27 North, Range 3 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to permit the production of gas from the Blanco Messaverte Pool and the production of gas from an undesignated Fractured Cliffs formation.

Now on this 17th day of November, 1958, the Secretary-Comptroller finds:

- (1) That application has been duly filed under the provisions of said section 101 of Rule 112-A of the Commission's Rules and Regulations
- (2) That satisfactory information has been provided that all necessary oil and gas acreage have been duly notified and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, Atlantic Petroleum Company, Inc., and the same is hereby authorized to dually complete the Liberty Well No. 1, located 990 feet from the South line and 990 feet from the West line of Section 35, Township 27 North, Range 3 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to permit the production of gas from the Blanco Messaverte Pool and the production of gas from an undesignated Fractured Cliffs formation, through parallel strings of tubing.

PROVIDED HOWEVER, that applicant shall complete, operate and produce said well in accordance with the provisions of Section V, Rule 112-A, as amended by Order 2-1514.

PROVIDED FURTHER, that applicant shall submit a flow-stability test upon completion and annually thereafter during the Annual Well-Stability Test Period for the Blanco Messaverte Pool.

IT IS FURTHER ORDERED: that payment of the costs of this order be retained by the Commission for such further order or orders as may be required.
