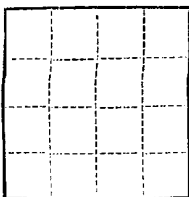

DETAILS OF WORK

5 1/2" at 2067' with 75 sacks regular cement, 75 sacks Pomsix.
