3. Set RBP above Pictured Cliffs perforations.
4. Pressure test casing.
5. Retrieve RBP above Pictured Cliffs perforations.
6. Run packer and frac string. Set packer above Pictured Cliffs perforations.
7. Acidize and fracture stimulate Pictured Cliffs formation.
8. Clean out wellbore.
9. Run 2-3/8", 4.70#, J-55, EUE tubing and set @ approximately 5,524'.
10. Return well to production.
