DETAILS OF WORK

It is intended to drill a well with rotary tools thru the Dakota formation. Mud circulation will be used thru the Mesa Verde and set intermediate casing. 10 3/4" at 170' with 150 sacks cement circulated to the surface.
7 5/8" at 4710' with 250 sacks cement.
5 1/2" liner at 7519' with 300 sacks cement.
