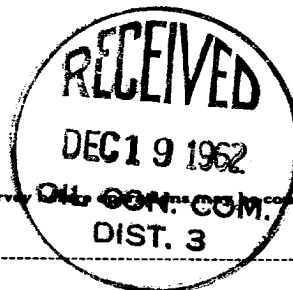

Cemented 1st stage w/226 sacks 1:1 Diamix & El Toro "35", 2% calcium chloride, 1/8# Celloflake/sk., Cemented 2nd stage w/203 sacks 1:1 Diamix & El Toro "35", 1/4 cu. ft. Strata-Crete "6"/sk., 1/8# Cello flake. Cemented 3rd stage w/172 sacks 1:1 Diamix & El Toro "35", 1/4 cu. ft. Strata-Crete "6"/sk., 1/8# Cello flake/sk. Held 1500#/30 minutes.
