THE APPLICATION OF EL PASO NATURAL GAS COMPANY FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS SAN JUAN 27-5 UNIT WELL NO. 37, LOCATED 800 FEST FROM THE NORTH LINE AND 840 FEST FROM THE RAST LINE OF SECTION 20, TOWNSHIP 27 NORTH, RANGE 5 WEST, NMPM, RIO ARRIBA COUNTY, NEW MEXICO, IN SUCE A MANNER AS TO PERMIT THE PRODUCTION OF GAS FROM AN UNDESIGNATED PICTURED CLIFFS POOL AND THE PRODUCTION OF GAS FROM THE BLANCO MESAVERDE POOL.



ADMINISTRATIVE ORDER OF THE OIL CONSERVATION CONMISSION

Under the provisions of Rule 112-A (c) El Paso Mitimal Gas Company made application to the New Mexico Oil Conservation Coumission on June 25, 1958, few permission to dually complete its San Juan 27-5 Unit Well No. 37, located 800 feet from the North line and 840 feet from the East line of Section 20, Toumship 27 North, Range 5 West, MAPM, Rio Arriba County, New Mexico, in such a manner as to permit the production of gas from an undesignated Pictured Cliffs Peol and the production of gas from the Blanco Messaverde Pool.

Now, on this 1st day of July, 1958, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Sub-section 'c' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acroage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the preposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consenant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, El Paso Natural Gas Company, be and the same is hereby authorised to dually complete its San Juan 27-5 Unit Well No. 37, located 800 feet from the North line and 840 feet from the East line of Section 20, Termship 27 North, Range 5 West, HMPM, Rio Arriba County, New Mexice, in such a manner as to permit the production of gas from an undesignated Pictured Cliffs Pool and the production of gas from the Blanco Mesaverde Pool, through the casing-tubing annulus and the tubing respectively.

PROVIDED HOMEVER. That subject well shall be completed and thereafter produced in such a manner that there will be no commingling within the well-bore, either within or outside the casing, of gas, oil and gas, or oil produced from either or both of the separate strata,

PROVIDED BOMEVER. That prior to the actual dual completion the operator shall make pressure tests of the easing to preve that no casing leaks exist. In the event a easing leak is apparent the operator shall take appropriate steps to adequately repair the leak. The results of these tests shall be reported to the Commission on Form C-103.

PROVIDED FURTHER. That upon the actual dual completion of such subject well applicant shall submit to the appropriate District Office of the Commission copies of Oil Conservation Commission Form C-103, Form C-104, Form C-110, and Form C-122, outlining the information required on these forms by existing Rules and Regulations, and two copies of the electric log of the well.

PROVIDED FURTHER. That said subject well for dual completion and production shall be equipped in such a way that reservoir pressures may be determined separately for each of the two specified strata, and further, be equipped with all necessary connections required to permit recording meters to be installed and used at any time as may be required by the Commission or its representatives, in order that natural gas, eil, or oil and gas from each separate stratum may be accurately measured and the gas-oil or gas-liquid ratio thereof determined, and

PROVIDED FURTHER. That the operator shall make any and all tests, including segregation and packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test Period for the Blance Mesaverde Peel, commencing in the year 1959, and whenever the packer is disturbed, but not excluding any other tests and/or determinations as deemed necessary by the Commission; the original and all subsequent tests shall be witnessed by representatives of offset operators if any there be at their election, and the results of each test, properly attested to by the applicant herein and all witnesses, shall be filed with the Commission within fifteen (15) days after the completion of such tests, and further, that applicant shall file with the Commission in duplicate a packer-setting affidavit, which affidavit shall be due within fifteen (15) days of the dual completion or whenever the packer is disturbed, and

PROVIDED FURTHER. That upon the detual dual completion of such subject well, applicant shall submit to the Commission a diagrammatic sketch of the mechanical installation which was actually used to complete and produce the seal between the strata, and a special report of production, gas-oil or gas-liquid ratio, and reservoir pressure determination for each producing some or stratum immediately following completion.

IT IS FURTHER ORDERED. That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order after proper notice and hearing the Commission may terminate the authority hereby granted and require applicant or its successers and assigns to limit its activities to regular single-some production in the interests of conservation.
