- 1) Move on location and rig up.
- 2) Unseated 2 7/8" retrievable packer and T.O.O.H. with 100 joints 1-1/4" tubing.
- 3) Spotted a 30 sx cement plug from 3529 to 2716'.
- 4) Perforated 2 7/8" casing at 172' and circulated a 45 sx cement plug to surface through the casing annulus.
- 5) Cut off well head and erected surface marker.
