On November 11, 1980, an Otis Perma Lach packer was set on 1 1/4" tubing in this well in order to temporarily repair a casing failure.

Since that time the well has been swabbed on 5 separate operations bringing up only water and no gas. The well is not capable of production and has not produced since August of 1980. At present, a proposal to plug and abandon is being prepared and is awaiting approval.
