DETAILS OF WORK

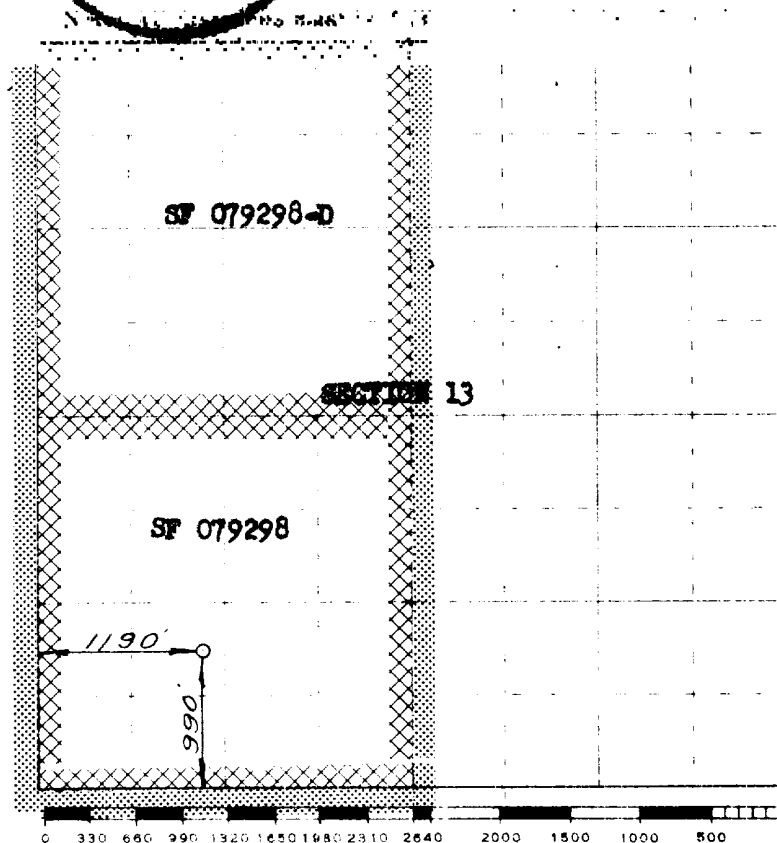
