DETAILS OF WORK

It is intended to drill a well with rotary tools through the Mesaverde, drilling the pay with gas circulation, and to shoot the entire Mesaverde with two quarts of S.H.G. per foot. Total depth 5425'.

9-5/8" at 160' with 125 sacks of regular cement circulated to surface.
7" at 4700' with 500 sacks of regular cement.

The W_{1/2} of Section 17 is dedicated to this well.
