

Mr. George Hatch of the Oil Conservation Commission was requested by letter, dated July 2, 1971, from you, to enter a case on the docket for the August 18, 1971, hearing to determine why the zones of the referenced dually completed well should not be separated or the well be properly plugged and abandoned.

Mechanical repair to provide separation of the zones was completed on July 19, 1971. The well is currently in the process of having a Packer Leakage test conducted on it. It is therefore requested that a case for this well not be entered in the above hearing.
